Accommodation for Persons in the Protection Process

Context

RIA was established in November 1999¹ to coordinate a scheme of dispersal and direct provision for asylum seekers. The Government decision underpinning this followed an earlier Government decision, based on the recommendations of the *Interdepartmental Working Group on the Integration of Refugees in Ireland.*

In 2018, the original basis of the Direct Provision (DP) system was fundamentally altered, by Ireland opting in to the EU's recast Receptions Conditions Directive. DP is no longer an ad-hoc process but (arising from the opting-in) is now placed on a statutory footing which comes with a series of standards and rights the DP system is obliged to deliver. Compliance is subject to inspection and invoking by the EU. Infringement proceedings can be issued by the EU for failure to comply adequately with the Directive. During the opt-in implementation process, various Departments and Agencies confirmed that the preparation of the necessary framework was in place by June 30th 2018, in order for Ireland to meet its compliance obligation. It is in this context that a review is timely to ensure on-going compliance with the new statutory framework within which DP operates.

The Direct Provision system under the Directive, implemented and coordinated by RIA, refers to a whole of Government approach to services provided to persons who present in Ireland seeking international protection (also known as asylum). A suite of services is offered by a range of stakeholders to applicants while their applications are being assessed to fulfil their legal obligations towards recipients or applicants. While the Reception and Integration Agency (RIA) provides material reception conditions (accommodation and related services), health services are provided through the HSE, education through the Department of Education and Skills, payments through DEASP and so on.

Ministerial Decision

In early 2019, an eSubmission entitled *Revised Paper on Accommodation for Persons in the Protection Process*, sought to highlight the difficulties being encountered with the current system. This led to a Ministerial decision to establish two committees:

1. Interdepartmental Group

Context:

Twenty years on from the initial establishment of RIA, given the recent placing of the service on a statutory footing subject to EU oversight, and given the current pressures being experienced, it is timely for the State to reconsider its response to managing persons seeking international protection in the context of its obligations under the Directive.

¹ RIA itself was actually established in 2001, replacing the body initially established – Directorate for Asylum Services (DASS).

Terms of Reference:

In the context of the State's commitment under the EU Recast Reception Conditions Directive, and the presenting pressures on the direct provision system, a committee is being established to:

- (i) Consider contingency options for the management of applicants for international protection should the volume exceed RIA's capacity to implement options (including Brexit related movement) in the context of the standards required by the Directive,
- (ii) Consider the short-to-medium term options which could be implemented in addition to, or in replacement of, the existing system to meet the compliance standards of the Directive.
- (iii) To review the implementation by all parties of the State's obligations under the EU Directive

2. Consultative Group

Context:

The McMahon Report (June 2015) issued substantive recommendations on improvements necessary within the protection process and direct provision systems. There is a need now to consider how to maintain the process of improvement inaugurated by the McMahon process as we move into the next phase of implementing the requirements of the Recast Reception Conditions Directive.

There are three aspects to this process.

(1) One is to implement the national standards recommended in the report. A standard-setting committee was established in 2017 and has now finished its work. The final draft set of standards, focusing on quality of life for applicants living in direct provision, has now been prepared for Ministerial approval.

- (2) Other Member States provide systems to support asylum seekers while in the protection process and often have to manage large volumes of residents and rapid variations in numbers. It would be useful to use the process to get information on the practices and systems in place in other European countries.
- (3) The recent fires in Rooskey and Moville point to the need to review how we engage with local communities and manage the relationship between those communities and the centres and the asylum seekers living within them. The advisory committee could advise on developing more positive community engagement with communities in which centres are currently or will be located.

Terms of Reference:

Building on the work of Justice Brian McMahon and his committee which produced the report Working Group to Report to Government on Improvements to the Protection Process, including Direct Provision and Supports to Asylum Seekers, a committee is being established to advise on the ongoing improvement of supports for asylum seekers.

The advisory group will have the following role:

- To advise on the implementation of the National Standards for the management of direct provision accommodation and to report to the Minister of State accordingly;
- To identify good practice in European countries in the provision of supports to asylum seekers within the protection process, particularly dealing with variations in demand;²
- To advise on developing positive relationships between local communities and the systems for supporting asylum seekers.
